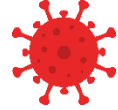


# ITC Conference Grants

CA17124 - DIGITAL FORENSICS: EVIDENCE ANALYSIS VIA INTELLIGENT SYSTEMS AND PRACTICES

Conference Grants (**up to 600 Euro**) are aimed at supporting PhD students and ECI researchers from Participating ITC to attend international science and technology related conferences not specifically organized by the COST Action.

The offer also applies to on-line conferences during **the COVID-19 pandemic time**.



## CRITERIA:

- **The Applicant is either a PhD student or an Early Career Investigator (ECI).**
- **The Applicant's primary affiliation in an institution located in an ITC (Inclusiveness Target Country).**
- **The Applicant must make an oral/poster presentation at the conference in question and must be listed in the official event/conference program.** The main subject of the oral presentation / poster presentation / speech at the approved conference **must be on the topic of the Action.** (see [COST Vademecum](#) Section 10, page 39).
- Considering the timeline of Grand Period, **conference for which the Applicant is applying must end latest in March 2021.**

## HOW TO APPLY?

During application, the **following steps** are provided:

- ▶ The applicant creates a [Conference Grant \(CG\) request](#).
- ▶ All applicants must send their submitted CG application form and the relevant supporting documents to CG Coordinator, for evaluation before the application submission deadline expires.

The list of **supporting documents to be submitted** in pdf format for the evaluation are:

- ▶ The submitted ITC **application form** (downloadable when the online application is submitted);
- ▶ A short **description of involvement in the COST Action**;
- ▶ **Acceptance letter** from the conference organizers (confirming either your speaking slot or your poster presentation);
- ▶ A copy of the **abstract or poster** submitted to the conference;
- ▶ A **Full C.V.** (including a **list of academic publications** – if applicable).

## EVALUATION

The application will then be assessed against the perceived contribution that the proposed Conference will make against the scientific objectives outlined in **the Action's [Memorandum of Understanding \(MoU\)](#)**.
